1 DESCRIPTION OF EVENT

Each racing day will represent a regatta.

The series will comprise of five regattas as outlined in the Schedule of Events.

2 RULES

The regattas will be governed by the rules as defined in The Racing Rules of Sailing including Appendix A4.1 Low Point System with 2 worst scores excluded if 8 races or more are completed.

3 ELIGIBILITY AND ENTRY

The Solo Winter Development Series is open to all the boats of the International 420 Class, International Laser Class (4.7, Radial, Laser), National 125 Class, International Optimist Class and Pelican Class whose skipper and crew are members of a yacht club which is affiliated with Yachting Western Australia and Yachting Australia.

Eligible boats may enter on the attached Entry Form which shall be lodged with the South of Perth Yacht Club On Water Group office **by 5.00pm Thursday 19th May**. Late entries received prior to 0900 on the morning of a boat's first race in the series may be accepted.

8 RACING AREA

Races will be short courses adjacent to the South of Perth Yacht Club known as Melville Water East.

9 PENALTY SYSTEM

Rules 44.1 and 44.2 are changed so that only one turn, including one tack and one gybe, is required.

10 PRIZES

After each regatta there will be a presentation of pennants to Open and Youth (U19 as of 22 May, 2011) in all fleets for 1st, 2nd and 3rd. At the end of the series major prizes will be awarded in all fleets based on combined results of each regatta, no regatta shall be excluded.

11 COACHING

Coaching in the 420 and Lasers will be permitted in between racing, Open competitors are also encouraged to assist Youth competitors between racing. Coaching in the 125, Pelican and Optimist's will be permitted during racing without interfering with other competitors.

12 DISCLAIMER OF LIABILITY

Competitors participate in the regattas entirely at their own risk. See rule 4, Decision to Race. The organising authority will not accept any liability for material damage or personal injury or death sustained in conjunction with or prior to, or after the regattas.
